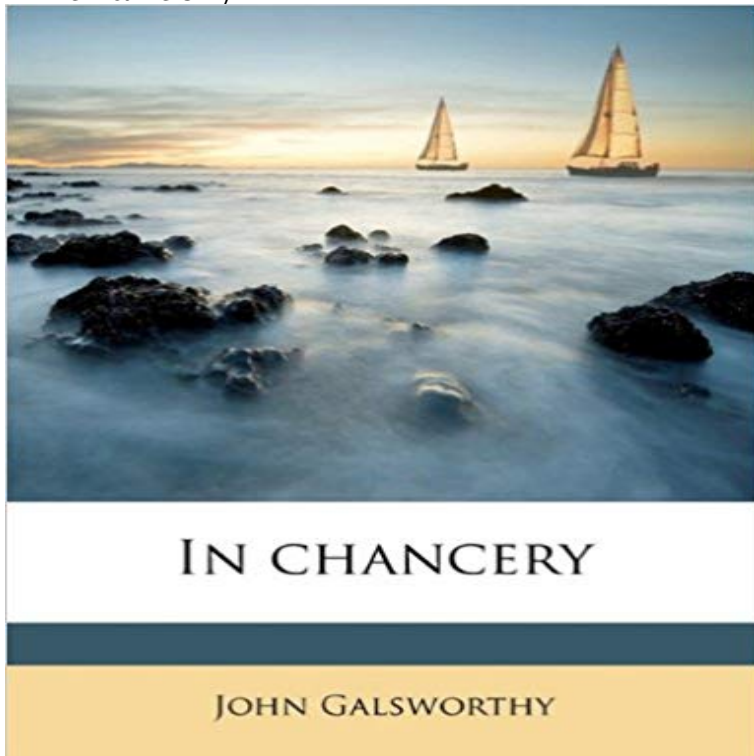


## In chancery
