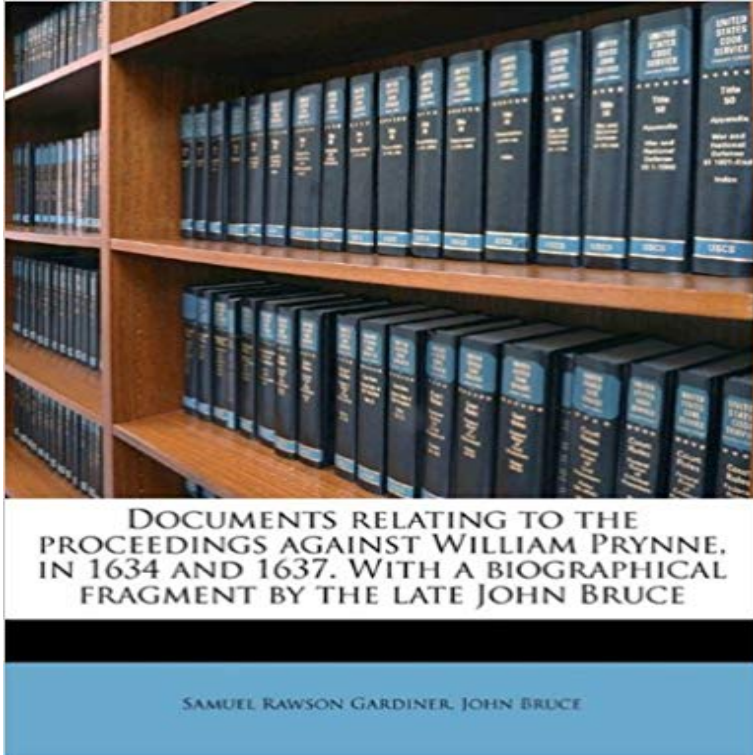


## Documents relating to the proceedings against William Prynne, in 1634 and 1637. With a biographical fragment by the late John Bruce
