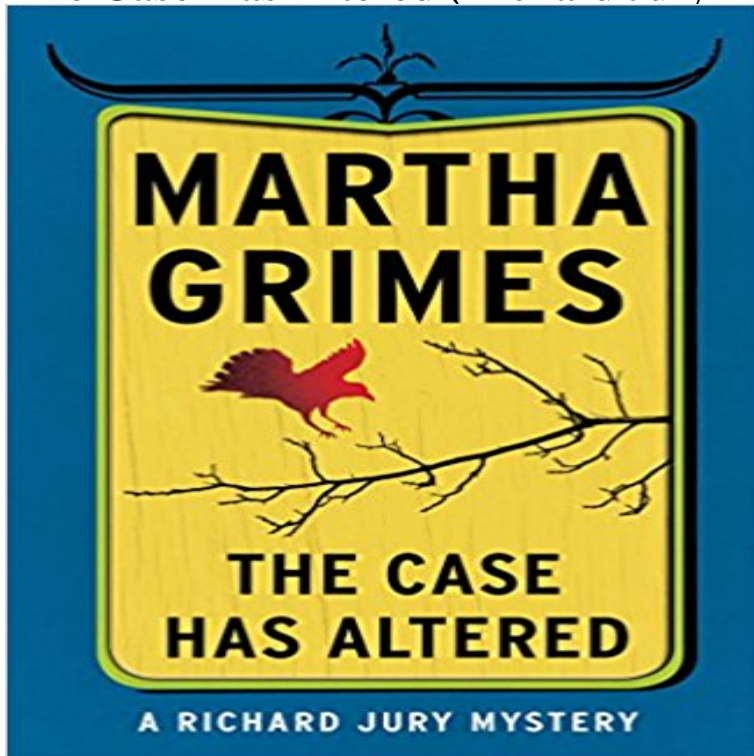


## The Case Has Altered (Richard Jury Mysteries Book 14)
